PARAGLIDING AND KITESURFING ACKNOWLEDGEMENT AND WAIVER

This is an important document and should be read with care and signed by all tandem paragliding passengers and students before embarking on any tandem flight or commencing any training.

1. Acknowledgment

The pilot/instructor and all at Wings & Waves are committed to making my flight/training as enjoyable and fulfilling as they can. I do understand and agree, however, as follows:

- Paragliding and Kite Surfing are potentially dangerous activities, and the risk of personal injury and death is real.
- I have disclosed to the pilot/instructor any physical or mental constraints (including disabilities) of mine which may mean I should not participate in this activity, or which the pilot/instructor may need to know, take into account in the flight/my training.
- Similarly, I will monitor my own fatigue, health, dehydration, hunger etc as it may affect my day's activity. Refer to [IMSAFE](#) as used in aviation.
- I understand that Wings & Waves has a strict drug and alcohol policy and I cannot participate in any activities if I am affected by drugs or alcohol. I declare that I am not affected by any drugs (incl. prescription drugs) or alcohol. I consent to drug testing instigated by W&W.
- I will comply with all instructions given by the pilot/instructor in connection with the flight/my training. I understand English well enough to follow instructions.
- If I fail to comply with any instruction given by the pilot/instructor, I accept that the flight/training may be terminated, and I may not be entitled to any refund (at the sole discretion of Wings & Waves).
- Paragliding and kitesurfing are weather dependant sports, and while the pilot / instructor will try to meet my expectations in relation to flight plan or instructions, content and duration, if weather conditions or safety issues arise the flight or training may have to be varied or shortened and no refund or other compensation will be paid.
- I agree that the decision to teach or fly, and change to the flight plan, lesson and/or duration, rests with the pilot/instructor.
- No course entitles to a license or sign off. Any skill assessments are made at the sole discretion of the instructors.
- If I am using my own equipment, I am responsible for its maintenance, that it's fit for the purpose and that it suits my weight and skill level.

In relation to kite surfing lessons:

- I can swim at least 200m distance. If not, please discuss options with your instructor.

In relation to tandem trial flights:

- The flight plan and procedures for the flight have been explained to me and I understand.



2. Limitation of Liability and Indemnity

To the full extent permitted by law, I agree:

- *Limitation of liability* – The full liability of the pilot/instructor, Wings & Waves Ltd and/or any agent or employee of them however it arises will be limited (in aggregate) to the cost of the tandem flight/course.
- *Consequential losses* – The pilot/instructor, Wings & Waves and all agents and employees of them will not be liable to me for any loss of income, indirect losses or other payment to cover purely financial or economic losses.
- *Third Parties* – If I cause any damage or loss to any third party, or create any liability for the pilot/instructor, Wings & Waves Ltd or any agent or employee of them, however it arises, to any third party, I will pay such third party all its costs resulting from or connected to such damage or loss upon demand and I will indemnify the pilot/instructor, Wings & Waves Ltd and/or any agent or employee of them for the consequences of any such liability.

If you are uncertain about the meaning or intention of this acknowledgement and waiver, please ask. Wings & Waves puts safety in all operations first.
